1 AN ORDINANCE relating to issuance of 90-Day
2 Permits for specific purposes; amending
3 Section 27.01, paragraph 3, King County
4 Resolution 18801; and repealing King
County Resolution 32303.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 Section 1. Section 27.01, Paragraph 3, Resolution
7 18801 is amended to read as follows:

8 ((3:--Temporary-Permits-may-be-issued-by-the-Board
9 for-specific-jobs-on-application-of-a-governmental-agency
10 covering-highway;-road;-street-and-airport-construction.
11 Such-permits-to-be-issued-after-a-report-from-the-County-Road
12 Engineer;-showing-that-the-work-is-in-the-public-interest.
13 Such-permits-to-be-issued-only-on-condition-that-the-most
14 modern-type-of-smoke-and-dust-collecting-equipment-will-be
15 provided-in-order-that-there-be-a-minimum-of-air-pollution
16 while-the-plant-is-operating:--When-excavation-is-permitted,
17 the-permittee-will-be-required-to-abide-by-all-of-the
18 regulations-contained-in-the-Washington-Standard-Specifications
19 for-Road-and-Bridge-Construction:--No-permit-to-be-issued-for
20 a-period-in-excess-of-ninety-(90)-days:))

21 3. Hereafter the Director of Buildings shall have
22 the authority to issue 90-day permits for specific jobs on
23 application of a governmental agency covering highway, road,
24 street and airport construction and for flood control. Provided,
25 however, that before any such permit shall issue, the application
26 shall be referred to the Department of Planning and the Department
27 of Public Works for their review and recommendations.

1 The Department of Public Works shall consider the
 2 effect of the proposed operation on the county road system and
 3 any effect it may have on flood control and the Department
 4 of Public Works shall made such recommendations as are necessary
 5 to protect the public interest in this regard.


6 The Department of Planning shall consider the effect
 7 of the proposed operation on the current and future land use
 8 in the area affected by the proposed operation and shall make
 9 such recommendations as are necessary to protect the public
 10 interest in this regard.

11 When issuing the permit, the Department of Buildings
 12 shall require compliance with the provisions of Ordinance 00525 ,
 13 the recommendations of the Department of Planning and the
 14 Department of Public Works, and shall be responsible for the
 15 enforcement of the provisions of the permit.


16 Section 2. King County Resolution 32303 is hereby


