SUBSTITUTE  
ORDINANCE NO. 1440

AN ORDINANCE correcting clerical errors in ordinances amending the 1972 budget, amending Ordinance No. 1355, Section 1; Ordinance No. 1305, Section 1; Ordinance No. 1056, Section 2, and General Grant Fund; and appropriating \$30,000 to the Human Rights Commission, and declaring an emergency.

SECTION 1. Ordinance No. 1355, Section 1, is hereby amended to read as follows:

"Supplemental appropriations in the amount of ((~~\$998,164~~)) \$960,189 to the River Improvement Fund, and ((~~\$186,626~~)) \$224,601 to the County Road Fund, are hereby approved and adopted, provided that said appropriations be utilized in accordance with the requirements of the Disaster Relief Act of 1970, Public Law 91-606."

SECTION 2. Ordinance No. 1056, Section 3, as amended, is hereby amended to read as follows:

SECTION 3. Ordinance No. 1305, Section 1, is hereby amended to read as follows to correct a clerical error by which the increase to the appropriation to the Bureau of Youth Affairs in the General Grant Fund was overstated by \$40:

"A supplemental appropriation in the amount of ((~~\$958,450~~)) \$958,410 to the Bureau of Youth Affairs, General Grant Fund, is hereby appropriated; provided that said appropriation be utilized solely for allowable expenses as specified in the agreement between King County and granting agency named herein."

SECTION 4. Ordinance No. 1056, Section 2, as amended, is hereby amended to read as follows to correct a clerical error in Ordinance No. 1344 by which the appropriation to Systems Services was overstated by \$100:
