AN ORDINANCE appropriating \$50,000 to the Current Expense Fund, Special Programs, and allocating a total of \$184,953 in Special Programs for reimbursement of Capital Funds charged for election costs of bond issues that failed and amending Ordinance No. 2230, Section 12, 14, 16, 18 and 49.

PREAMBLE:

It has been determined that election costs incurred by bond issues which fail shall be paid by the Current Expense Fund, and reimbursements made to funds incorrectly charged for these costs.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$50,000 to Special Programs in the Current Expense Fund from reductions in appropriations to other Current Expense Fund divisions as detailed below.

SECTION 2. Within the appropriated and available funds within Special Programs, \$184,953 shall be used to reimburse Capital Funds charged for election costs of bond issues that failed: Youth Service Development Fund - \$259; Arterial Highway Development Fund - \$12,352; Park Acquisition and Development Fund - \$16,416; Stadium Development Fund - \$155,925.

SECTION 3. Ordinance No. 2230, Section 49 is hereby amended to read as follows:
