8 ORDINANCE NO. 3359

9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map thereof
11 reclassifying certain property thereon at the request of
12 James & Marlene Daily, Building and Land Development
13 Division File No. 127-77-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. James & Marlene Daily petitioned on March 14, 1977, that
15 the property described in Section 3 below be reclassified from SR (Potential
16 RM 900) to RM 900 and this application was assigned Building and Land Develop-
17 ment Division File No. 127-77-R.

18 SECTION 2. The report and recommendation of the Building and Land
19 Development Division was transmitted to the Zoning and Subdivision Examiner
20 on May 3, 1977, and hearing was held by the Examiner on the matter May 10,
21 1977. The report of the Examiner was filed with the Clerk of the King County
22 Council on June 2, 1977, and the Council approved the reclassification by
23 Motion No. 3062 on June 6, 1977, subject to conditions which will be satisfied
24 per the "P" suffix.

25 SECTION 3. The legal description of the property to be reclassified is attached
26 as Appendix A and is hereby made a part of this ordinance. The above described
27 property is shown on the attached map which is designated Appendix B and is here-
28 by made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County Zoning
30 Code, Resolution No. 25789, as amended, by reclassifying that property described
31 and shown in Section 3, Appendices A and B above, to RM 900-P and directs that Area

1 Map E 4-25-5 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in

3 Motion No. 3062 which will be satisfied per the "P" suffix.
