AN ORDINANCE relating to the annexation of an
5 area known as P-247 to Cascade Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of
an area known as P-247 to Cascade Sewer District was
filed with the County Council effective February 23,
9 1978.

2. Cascade Sewer District has found the petition for
annexation to be sufficient and has, by Resolution 766,
concurred with the proposed annexation.

3. Cascade Sewer District filed a Declaration of
Nonsignificant Impact dated December 15, 1977.

4. The County Council held a public hearing on the
3rd day of April, 1978, and
has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the
area known as P-247 and described in Section 2 herein is approved.

SECTION 2. Any prior approval of Cascade Sewer District's
general comprehensive sewer plan for the area known as P-247 is
hereby rescinded, and a revised general comprehensive plan shall
be submitted showing sewer service by gravity to existing sewer
facilities.

SECTION 3. The area known as P-247 to be annexed is described
as follows:

Beginning at the corner common to Sections 23, 24, 25,
and 26, Township 22 North, Range 5 East, W.M., King
County, Washington, said point being on the existing
boundary of Cascade Sewer District.

Thence Easterly along the North line of Section 25
also being the centerline of S.E. 256th ST. to the
East line of the West three quarters of the Northwest
quarter of the Northwest quarter of said Section 25;

Thence Southerly along said East line and along the
East line of the West three quarters of the North half
of the North half of the Southwest quarter of the

Northwest quarter of said Section 25 to the South line thereof;

Thence Westerly along said South line to the West line of said Section 25; also being the East line of Section 26;

Thence Northerly along said East line to the South line of the Northeast quarter of the Northeast quarter of the Northeast quarter of said Section 26;

Thence Westerly along said South line to the West line of the East half of the Northeast quarter of the Northeast quarter of the Northeast quarter of said Section 26;

Thence Northerly along said West line to the North line of said Section 26;

Thence Easterly along said North line to the Point of Beginning.
