17 AN ORDINANCE amending King County Title 21, as
18 amended, by amending the Zoning Map, thereof
19 adopting a Final Planned Unit Development on
20 certain property thereon at the request of S. J.
AND I. COPPO, Building and Land Development File
No. 235-78-P (KENTON FIRS DIVISION #2)

21 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

22 SECTION 1. S.J. & I. COPPO petitioned on November 22, 1977,
23 that the planned unit development be adopted on property described
24 in Section 2 below, and this application was assigned Building and
25 Land Development Division File No. 235-78-P.

26 SECTION 2. The legal description of the property designated
27 is attached as Appendix A, and is hereby made a part of this
28 ordinance. The above described property is shown on the attached
29 map, which is designated Appendix B, and is hereby made a part of
30 this ordinance.

31 SECTION 3. The King County Council does hereby amend King
32 County Title 21, as amended, by adopting the planned unit develop-
33 ment for that property described and shown in Section 2, Appendices

1 A and B above, to Planned Unit Development, and directs that the
2 Area Map E 17-22-5 be modified to so designate. The land use
3 authorized by this ordinance shall become effective upon the
4 recording of a Final Planned Unit Development site plan by the
5 Manager of the Building and Land Development Division.
