ORDINANCE NO. **9021**

AN ORDINANCE establishing the 1989 appropriation authority for the Office of Capital Planning and Development, and authorizing the 1989 FTE level; amending Ordinance No. 8802, Section 16, 28, and 92 as amended, adding two new sections, and repealing Ordinance 8984.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:






