ORDINANCE NO. 751

S.W. 106th ST. & S.W.  
107th ST. (24th AVE. S.W.)  
TO 22nd AVE. S.W.)  
County Road

In the matter of the establishment of S.W. 106th Street and S.W. 107th Street  
(24th Avenue S.W. to 22nd Avenue S.W.) county road the Council finds as follows:

First. That the † Motion No. 420 therefore was \* passed on the  
first day of February, 19 71, and the County Engineer was duly directed to  
examine and if necessary survey the route of said proposed road.

Second. That on the 20th day of January, 19 71, the County  
Engineer filed in the office of the Council his report in writing, and at the same time his field notes and  
profiles of the proposed road, and a map, as provided by law, and the 8th day of March,  
19 71, was set as the day for hearing on said report, and notice of such hearing was duly given by  
publishing and posting as provided by law.

Third. That the Council, having considered said report and all evidence relative to the establishment  
of the road, and finding that such proposed road is a public necessity.

IT IS ORDERED BY THE COUNCIL, that the S.W. 106th Street and S.W. 107th Street  
(24th Avenue SW to 22nd Avenue SW) Road be established as follows:

Beginning at a point on the centerline of 24th Avenue  
S.W. at a point which bears S. 67°08'52" W. a distance  
of 2129.59 feet from the east quarter corner of Section  
1, Township 23 North, Range 3 East, W.M.; thence in an  
easterly direction a distance of 465.97 feet to a  
terminus at the intersection of 22nd Avenue S.W. and S.W.  
107th Street, said terminus bears S. 57°02'17" W. a  
distance of 1915.62 feet from said east quarter corner  
of said Section 1.

465.97 feet = 0.09 mile

and as shown upon the field notes, profile and map of the County Engineer, and that from henceforth said  
road shall be a County Road of not less than 84 feet in width exclusive of slopes for cuts  
and fills, and that the same be opened according to law.
