

SUBSTITUTE ORDINANCE  
NO. 1270

AN ORDINANCE amending King County Zoning Code Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of WILLIAM MYERS, et al, Department of Planning File No. P-70-41.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. William Myers, et al, petitioned March 9, 1970 that the property described in Section 3 below be reclassified from RS-7,200 (Potential RM-2,400) to RM-2,400 and this application was assigned Department of Planning File No. P-70-41.

SECTION 2. The report and recommendation of the Department of Planning was transmitted to the Zoning & Subdivision Examiner April 28, 1970 and hearing was held by the Examiner on this matter May 5, 1970. The attached report of the Examiner was filed with the Clerk of the King County Council May 20, 1970.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map, designated as Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend the King County Zoning Code, Resolution No. 25789, by reclassifying that property described and shown in Section 3, Appendices A and B above,

LEGAL DESCRIPTION






