BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Section 1. Pursuant to traffic engineering studies, Schedule 5, which sets maximum speed limit at 45 miles per hour on county roads, is amended to add the following street.

PRESTON-FALL CITY ROAD, between a point 670 feet north of Southeast 86th Street and David Powell Road.

Section 2. Signs posted to evidence the above described speed limit be installed by the proper authority.
