ORDINANCE NO. 1556

1 AN ORDINANCE relating to the annexation of  
2 certain areas contiguous to King County Water  
3 District No. 124 (No. 71.100.3 and No.  
4 71.100.9) to King County Water District No.  
5 124.

6 WHEREAS, King County Water District No. 124 has found the  
7 petitions for annexation of certain areas contiguous to King  
8 County Water District No. 124 (No. 71.100.3 and No. 71.100.9) to  
9 be sufficient and has, by its Resolutions No. 65 and No. 69, con-  
10 curred with the proposed annexation; and

11 WHEREAS, state law requires approval of the proposed  
12 annexation by the King County Council and the King County Boundary  
13 Review Board; and

14 WHEREAS, the King County Council finds said annexation is in  
15 the public interest and is not inconsistent with the county compre-  
16 hensive plan, the basinwide water plan, and the county plan for  
17 water facilities;

18 THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

19 SECTION 1. The annexation by King County Water District No.  
20 124 of the territory contiguous to King County Water District No.  
21 124 (No. 71.100.3 and No. 71.100.9) and described in Section 2  
22 herein is approved.

23 SECTION 2. The territory to be annexed is described as  
24 follows:

25 PARCEL NO. 71.100.3

26 Beginning at the Southeast corner of the North 1/2 of  
27 Government Lot 5, Section 6, Township 21 North, Range  
28 4 East, W.M.; thence Northerly along the East line of  
29 said Lot 5 to its intersection with the centerline of  
30 Marine View Drive; thence Northeasterly along said  
31 centerline to its intersection with the South line of  
32 the North 340 feet of the Northeast 1/4 of the South-  
33 west 1/4 of said Section 6; thence Westerly along said  
South line and the South line of the North 340 feet of  
said Lot 5 to the West line of said Section 6; thence  
Southerly along said West line to the South line of  
the said North 1/2 of Government Lot 5; thence Easterly  
along said South line to the Southeast corner of said  
North 1/2 and the Point of Beginning, King County,  
Washington.

1 PARCEL NO. 71.100.9

2 Lots 6 through 11, Block 6, Marine View Estates,  
3 according to plat thereof recorded in Volume 44 of  
4 plats, pages 59 and 60, records of King County,  
5 Washington, and adjoining streets, King County,  
6 Washington.
