21 DIVISION - From the children and family set-aside fund there is hereby appropriated to:

24 Of this appropriation, (~~(\$14,959,620)~~) \$16,829,620 shall be expended solely for
25 contracts with the agencies and in the amounts listed below. For contracts that were
26 included in the executive's 2006 proposed budget, a variance of up to ten percent from
27 the amounts listed below may be adjusted administratively without council approval.
