NOW, THEREFORE, in consideration of the premises, the said Grantor hereby agrees that the said slopes may be made on his property as herein-before set forth, in conformity with standard plans and specifications for highway purposes and to the same extend and purposes as if the rights herein granted had been acquired by condemnation proceedings under Eminent Domain statutes of the State of Washington.

IT IS MUTUALLY AGREED AND UNDERSTOOD by the parties hereto that this Easement has been given to and accepted by said County subject to and upon the following conditions to-wit:

If any part of said right of way shall be abandoned or shall cease to be used or maintained as a public highway by said county, or the route thereof changed, then as to such part all rights under this easement shall thereafter be null and void, and such portions of such right of way shall automatically revert to the GRANTORS their successors, or assigns without any notice being required.
