A MOTION AUTHORIZING APPLICATION FOR FUNDING ASSISTANCE FOR OUTDOOR RECREATION PROJECTS TO THE WASHINGTON STATE INTERAGENCY COMMITTEE FOR OUTDOOR RECREATION AS PROVIDED BY THEIR OUTDOOR RECREATION FUND ACCOUNT.

WHEREAS, the Board of County Commissioners, King County, Washington, approved the Ten-year Program for Open Space Acquisition by Resolution No. 35155 which identifies the following major urban parks for acquisition under the 1969-1970 priority:

- 3. Kenmore Park -- I.A.C. #69-126 A, 18 acres on Swamp Creek near Kenmore Elementary school.
- 4. N. C. W. Lake Sammamish -- I.A.C. #69-127 A, 10 acres on west side of Lake Sammamish.
- 5. S. C. W. Lake Sammamish -- I.A.C. #69-128 A, 25 acres on southwest side of Lake Sammamish.
- 6. Lakota Beach -- I.A.C. #69-129 A, 50 acres on Puget Sound west of Federal Way.
- 7. May Creek Stage #1 -- I.A.C. #69-130 A, 166 acres in May Creek Valley north of Renton.
- 8. Normandy Beach -- I.A.C. #69-131 A, 30 acres on Puget Sound southwest of city of Normandy Park.
- 9. North Green River -- I.A.C. #69-132 A, 100 acres on Green River south of city of Kent.
- 10. Richmond Beach -- I.A.C. #69-133 A, 2 acres on Puget Sound north of existing Richmond Beach Park.

WHEREAS, under the provisions of the Washington State Interagency Committee for Outdoor Recreation's funding account and federal funding assistance have been authorized and are available to aid in financing the cost of land for parks and construction of outdoor recreational facilities of local public bodies, and
