

## M O T I O N

WHEREAS, the County Council of King County, Washington considers useless as a part of the general road system of King County, those portions of streets in the vicinity of the Seattle-Tacoma Airport hereinafter more particularly described, now, therefore

BY MOTION the County Council declare their intention to vacate and abandon for public use those portions of streets described as follows:

1. 16th Ave. So. lying between the south right of way margin of So. 146th St. and the north right of way margin of So. 154th St.
2. 24th Ave. So. lying between the south right of way margin of So. 154th St. and the south right of way margin of So. 160th St.
3. 25th Ave. So. and 25th Pl. So. lying between the south right of way margin of So. 154th St. and the north right of way margin of So. 156th St.
4. So. 156th St. lying between the east right of way margin of 24th Ave. So. and the east right of way margin of 30th Ave. So.
5. That portion of 25th Pl. So. lying south of the south right of way margin of So. 156th St. and lying within the plat of Triana Terrace (Vol. 64 of Plats, pg. 12).
6. 26th Ave. So. lying between the south right of way margin of So. 156th St. and the north right of way margin of So. 158th St.
7. 28th Ave. So. lying between the south right of way margin of So. 156th St. and the north right of way margin of So. 158th St.
8. So. 156th Pl. lying east of the east right of way margin of 28th Ave. So. and lying within the plat of Lenora Lane (vol. 11 of Plat, pg. 85).
9. 29th Ave. So. lying south of the south right of way margin of So. 156th St. and lying within the Plat of Linda Addition (Vol. 58 of Plats, pg. 86).
10. So. 156th Pl. lying west of the west right of way margin of 29th Ave. So. and lying within the Plat of Linda Addition (Vol. 58 of Plats, pg. 86).
11. 30th Ave. So. lying between the south right of way margin of So. 156th St. and the north right of way margin of So. 158th St.
12. S. 157th St. lying east of the east right of way margin of 24th Ave. So. and lying within the Plat of Spencer View Addition (Vol. 48 of Plats, pg. 50).


- 13. So. 158th St. lying east of the east right of way margin of 24th Ave. So. and lying west of the east right of way margin of the Airport Access Freeway, said east right of way margin being located approximately at the west line of the Plat of Lowe's Terrace No. 14 (Vol. 56 of Plats, pg. 67).
- 14. 28th Ave. So. lying south of the south right of way margin of So. 158th St. and lying within the Plat of Glenroy Acres (Vol. 51 of Plats, pg. 82).
- 15. So. 160th St. lying east of the east right of way margin of 24th Ave. So. and lying westerly of the east line of the S.W.<sup>4</sup> of the S.E.<sup>4</sup> of section 21, TWP. 23N., RG. 4E., W.M., and lying westerly of the east line of the NW<sup>4</sup> of the NE<sup>4</sup> of section 28, TWP. 23N., RG. 4E., W.M.
- 16 So. 170th St. lying east of the east right of way margin of vacated 24th Ave. So. and lying west of a line that is 734.84 ft. east of and parallel to said east right of way margin of vacated 24th Ave. So.

and that a hearing on this matter be fixed for the regular meeting of the Council to be held on the 26<sup>th</sup> day of January 1970, and the Clerk of the Council is hereby directed to post and publish notice thereof pursuant to law, and the Director of Public Works is directed to report upon such vacation and abandonment at said hearing.
