MOTION PROVIDING BINDER IN CONNECTION WITH COMPLIANCE AUGURANTS. WITH THE RELOCATION ASSISTANCE PROVISIONS OF THE UNIFORM RELOCATION ASSISTANCE AND REAL PROPERTY ACQUISITION POLICIES ACT OF 1970

WHEREAS, the Uniform Relocation Assistance and Pow Property Acquisition Policies Act of 1970, P. L. 91-646, (hereinafter called the "Act") establishes uniform policies for the fair erro equitable treatment of individuals, partnerships, corporatic or associations (hereinafter called "displaced persons") who are displaced as a result of Federal and Federally assisted programs; and

WHEREAS, the Act is applicable to various programs and over jects (hereinafter called the "undertaking(s)") receiving financial assistance from a Federal Agency such as the opercount of Housing and Urban Development (hereinafter called "hous"); and

WHEREAS, this governing body seeks financial assistance pursuant to undertaking(s) identified below, subject to the set and administered by HUD; and

WHEREAS, the activities for which such assumance is so and will involve displacement occurring on or after January 2, 1971, the effective date of the Act; and

WHEREAS, Section 210 of the Act requires the receipt of pertain assurances before the head of a Federal agency can provide financial assistance to pay all or part of the cost of any undertaking(s) which will result in displacement as defined in the Act.

NOW THEREFORE, be it resolved by the County Council of King County, Washington, as follows:

A. This governing body hereby agrees that (1) within 96-days of the date hereof it will provide an opinion of its chief legal counsel with respect to its ability to comply under state or local law with the requirements of Section 210 of the Uniform Relocation Assistance and Real Property Act of 1970 (Public Law 91-646, hereafter called the "Act"); and (2) in the event that it is determined that this body is able to comply with Section 216 at shall execute and provide the assurances set forth in said Section 210. This body further agrees (1) where the State Attorney General has issued an opinion on a question of interpretation of State law which is at issue in making a determination of its ability to comply with the requirements of Section 210 of the Act, it shall be guided by such opinion; and (2) nothing herein or in any contract or agreement of which this Binder is made part shall be construed to delay such Agency's obligation to comply with the requirements of Section 210 with respect to the displacement of such displaced persons occurring after July 1,11972.

B. This document is hereby made a part of and is incorporated in the financial assistance agreements between this public body and HUD for the undertakings identified below and shall be deemed to supersede any provisions in said agreements to the extent that such provisions may conflict with the assurances or agreements provided hereunder.
