WHEREAS, it is further deemed necessary that nationally recognized attorneys experienced in such matters be retained as bond counsel to participate with the King County Prosecuting Attorney in drafting the ordinances, notices and other documents necessary for the issuance, sale and delivery of said bonds, and to give their opinion as to the validity thereof at the time of their sale;

Prosecuting Attorney in drafting the ordinances, notices and other documents required by the County for the issuance and sale of its Various Purpose General Obligation Bonds in the total principal amount of \$17,283,000, payable from annual tax levies to be made without limitation as to rate or amount and issued to provide the money necessary to pay part of the cost of acquisition, development and improvement of the public park and recreation facilities authorized by Resolution No. 34571 of the County and part of the cost of acquisition, development and improvement of public arterial highway facilities authorized by Resolution No. 34569 of the County, all as duly approved by the qualified electors of the County at a special election held therein on February 13, 1968. The legal services to be rendered by bond counsel will include participation in the drafting of all ordinances, notices and other documents required for the issuance, sale and delivery of the bonds and the furnishing of their opinion as to the validity of such bonds at the time of their delivery.

BE IT FURTHER MOVED that the County shall pay bond counsel as compensation for their services the sum of \$13,100 together with any actual out-of-pocket expenses incurred by them in performing such services, other than office overhead. Payment shall be made out of proceeds of the sale of the bonds when and as issued. The County shall furnish bond counsel at their office in Seattle, Washington, with a complete certified transcript of all proceedings taken in the issuance of the bonds.
