A MOTION authorizing the County Executive to enter into an agreement with the City of Seattle and United Way of King County entitled, "Agreement Establishing an Official Planning Agency for Aging for the Seattle-King County Planning and Service Area" and repealing Motion No. 1120.

WHEREAS, the Washington State Office on Aging has desig-

nated King County as an Official Planning and Service Area, and WHEREAS, within this Planning and Service Area an Official Agency is to be designated to carry responsibility for planning and coordinating of all programs and services for older persons in cooperation with said State Office on Aging and with appropriate federal agencies, especially the Regional Office of the Administration on Aging of the United States Department of

WHEREAS, it is to the mutual interest of King County, the City of Seattle and United Way of King County to recognize the City of Seattle's Department of Human Resources, Division on Aging, as the official Planning Agency in the Seattle-King County Area,

Health, Education and Welfare, and

NOW, THEREFORE, BE IT MOVED by the Coucil of King County: Motion No. 1120 is hereby repealed.

The King County Executive is hereby authorized to execute the agreement herein attached, entitled, "Agreement Establishing an Official Planning Agency for Aging for the Seattle-King County Planning and Service Area," which by this reference becomes a part of this Motion.

AGREEMENT ESTABLISHING AN OFFICIAL PLANNING AGENCY FOR AGING
FOR THE SEATTLE-KING COUNTY PLANNING AND SERVICE AREA

Section I: It is mutually agreed upon by The City of Seattle, the County of King and The United Way of King County that the Division on Aging, Department of Human Resources of The City of Seattle, acting with the guidance of the Planning Council hereinafter provided for, is an appropriate agency to be designated as The Official Planning Agency on Aging for the Seattle-King County Planning and Service Area, pursuant to the State Plan for Aging of The Washington State Office on Aging.

Section II: There is hereby created a Seattle-King County Plannin Council on Aging, to be composed of twenty-four (24) members, one-third (8) to be appointed by the Mayor, City of Seattle, and confirmed by the City Council, one-third (8) to be appointed by the King County Executive and confirmed by the County Council and one-third (8) to be appointed by the President of United Way of King County and confirmed by the Board of United Way, provided that the first eight appointments of United Way shall be made in consultation with the Executive Committee of the Seattle-King County Council on Aging.

- A. Appointees shall be at least 51% persons over the age of 55, including persons representing minority and low income elderly
- B. Each member so appointed shall serve for a term of two years, provided that of the first members so appointed, twelve (12) shall be appointed for a one year term; and twelve (12) shall be appointed for a two year term; provided further that no person shall be appointed to more than three consecutive two year terms; provided further that any vacancy shall be filled for the unexpired term in the same category as the original appointment.

Section III: The Planning Council shall organize, elect officers and adopt such rules and procedures, consistent with the City Charter of Seattle, and the provisions of this agreement, as are necessary for the conduct of its affairs and performance of its functions and responsibilities which shall be as follows:

- A. To serve as an advocate body on behalf of older persons within the Seattle-King County Planning and Service Area.
- B. To determine and prioritize needs and make recommendations based thereon for services with special consideration for minority and low income elderly.
- C. To provide guidance to the staff of the Division on Aging in the development and implementation of the Area Plan on Aging consistent with federal and state regulations, the term of this agreement, and the Charter, ordinances and policies of the City of Seattle and of King County; provided that such guidance shall not constitute an independent executive power.
- D. To present, yearly, recommendations to the Mayor, City of Seattle, the King County Executive, and the President of United Way, for a comprehensive Area Plan on Aging for the Seattle-King County Planning and Service Area, and request adoption of such plan by the Seattle City Council, the King County Council, and the United Way of King County.
- E. To make recommendations on all matters related to government financial grant applications and contractual arrangements necessary to the implementation of the Seattle-King County Area Plan.
- F. To develop guidelines for an areawide Citizen Participation system under the Comprehensive Area Plan on Aging in order to insure broad and effective participation of local consumers in the Process of Planning, developing and administering programs in the various sub-areas or neighborhoods.
- G. To plan and coordinate on a continuous basis with all public and private policy makers and providers of services to the elderly in the Seattle-King County Planning and Service Area, with an emphasis on the development of a climate of productive cooperation and minimizing the duplication of efforts and unwarranted organizational competition.
- H. To appoint subcommittees for periods not to exceed six
  (6) months for special purposes such as facilitating subarea and special project planning, which may include
  members other than Planning Council members, by appointment
  of the chairman.
- I. To develop criteria for use in periodic evaluation of activities carried out pursuant to the Area Plan on Aging in order to maximize the effective use of available public and private resources.
- J. To sponsor and conduct public hearings, conferences and other such meetings designed to obtain and publicize information related to the problems, accomplishments and interests of older persons.

The Planning Council shall meet at least once each month at such time and place as the Chairman thereof shall designate, and all meetings shall be open to the public.

Section IV: The Division on Aging, Department of Human Resources, of The City of Scattle, shall discharge the following responsibilities:

A. To coordinate and provide staff support to the Seattle-King County Planning Council on Aging in order to facilitate effective citizen and consumer participation in the process of planning and policy making related to the Area Plan on . Aging.

- B. To develop and implement in coordination with the Planning Council, a Comprehensive Area Plan on Aging, to include the administration of a coordinated system for the delivery of social and nutritional services within the planning and service area of Seattle-King County, provided that the Department of Human Resources as the Planning Agency shall not operate service programs.
- C. To plan and coordinate on a continuous basis with all public and private policy makers and providers of services to the elderly in the Seattle-King County Planning and Service Area
- D. To render technical assistance to all agencies covered by the Area Plan.
- E. To evaluate and monitor activities carried out pursuant to the Area Plan on Aging and to report the results of such to the Planning Council on Aging.
- F. To exercise administrative authority and to receive and disbufunds necessary to the implementation of The Area Plan on Agiconsistent with the Charter, ordinances and policies of the City of Seattle.
- G. To provide staff support to the Seattle-King County Planning Council on Aging.
- H. To consult with the Planning Council when selecting staff, provided, however, the Director of Human Resources shall make all appointments.

Section V: Financing for the Department of Human Resources,
Division on Aging as the Planning Agency shall be provided by a grant
from The State Office on Aging to be appropriated by ordinance for
the purpose of implementing such agency with a local match provided
by The City of Seattle in such sums as may be appropriated therefor.
Additional grants received from the State or Federal government,
intended for the purchase of direct services for the elderly, shall
be administered by the Department of Human Resources, Division on
Aging pursuant to such ordinances as may be enacted from time to time
for the purpose of appropriating such grants for said services.
Required matching funds shall be sought from the operating agency
or governmental jurisdiction receiving a subcontract for the provision
of services to the elderly and shall not be the sole responsibility

of The City of Seattle.

Section VI: Any party may request an amendment to this agreement or this agreement may be terminated by any of the parties upon thirty (30) days written notice. In the event of such termination any equipment, supplies or personal property acquired pursuant to this agreement shall become the sole property of The City of Seattle.

Section VII: That this agreement shall take effect upon the date of its execution given below, and shall be in continuous effect in perpetuity or until termination of the agreement as herein provided.

IN WITNESS WHEREOF, this agreement is executed by the chief executive officers of the parties hereto, listed below, and shall have full force and effect from and after -----, subject to the termination provisions contained herein.
