A MOTION authorizing the County Executive to execute on behalf of King County, Amendment No. 1 to the Grant Agreement between King County and the Federal Aviation Administration regarding Special Condition No. 13, Project No. 8-53-0058-02.

WHEREAS, the Federal Airport Act of 1946 (49 USC 1101 et seq) provides for the making of grants by the Federal Aviation Administration, Department of Transportation, to assist in bringing about the establishment of a nationwide system of public airports adequate to meet present and future needs of civil aviation and to be in conformity with the national airport plan, and

WHEREAS, the Federal Aviation Administration (FAA) has determined that the existing Grant Agreement between King County and the FAA, Project No. 8-53-0058-02, should be amended, and

WHEREAS, the County Council agrees to the proposed amendment relating to Special Condition No. 13.

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- 1. That King County shall enter into an agreement with the United States called Amendment No. 1 to Grant Agreement for Project No. 8-53-0058-02 for the purpose of changing Special Condition No. 13 of the contract executed on June 15, 1972.
- 2. That the King County Executive is hereby authorized and directed to execute said Amendment No. 1 to Grant Agreement on behalf of King County and the Director of Records and Elections is hereby authorized and directed to attest the signature of the County Executive and to impress the official seal of the King County on said Amendment No. 1 to Grant Agreement at the place marked "(SEAL)".

AMENDMENT NO. 1 TO GRANT AGREEMENT

WHEREAS, the Federal Aviation Administration (hereinafter referred to as the "FAA"), acting for and on behalf of the United States of America, has determined that, in the interest of the United States, the Grant Agreement relating to the above numbered project between the United States and the County of King, Washington, (hereinafter referred to as the "Sponsor"), accepted by the Sponsor on June 15, 1972, should be amended as hereinafter provided:

NOW, THEREFORE, WITNESSETH:

That in consideration of the benefits to accrue to the parties hereto, the FAA, acting for and on behalf of the United States on the one part, and the Sponsor, on the other part, do hereby mutually agree that said Grant Agreement be and hereby is amended as follows:

Special Condition No. 13 is deleted in its entirety and replaced with the following new Special Condition No. 13:

"13. It is understood and agreed hereto that in the event during the term or duration of the Grant Agreement for this project it becomes necessary to remove, relocate, or otherwise replace the storm drain trunk line now in existence between Boeing Field International Airport and Slip 6, the sponsor will, without Federal participation, remove, relocate, or otherwise replace the subject storm drain trunk line provided that said action is made necessary by action of the land owner under the terms of the easement dated March 25, 1932."
