A MOTION initiating the creation of a joint Flood Control Zone District in Pierce and King Counties; describing the boundaries of such proposed zone; describing general flood control needs within the zone; and setting a date for public hearing.

WHEREAS, RCW 86.15 provides for the creation of flood control zone districts by county boards of commissioners; and,

WHEREAS, the Interlocal Cooperation Act, set forth in RCW 39.34, allows counties to exercise jointly any powers which each county may exercise separately, and

WHEREAS, the King County Boundary Review Board, on May 31, 1973, and the Pierce County Boundary Review Board, on July 24, 1973, after public hearings, unanimously adopted resolutions approving the creation of the proposed joint flood control zone district in the Hylebos Drainage Basin, and

WHEREAS, the King and Pierce County Boundary Review Boards found that the logical service area for the proposed joint flood control zone district is ideally the entire drainage basin, and the boundaries of the proposed district do follow as nearly as practicable the actual boundaries of the Hylebos Drainage Basin, and

WHEREAS, a joint flood control zone district would be of special benefit to the Hylebos Drainage Basin area of Pierce and King Counties,

NOW THEREFORE, BE IT MOVED by the Council of King County:


A joint flood control zone district is needed in the Hylebos Drainage Basin to protect life and property within the Basin from water damage and to control, conserve, retain and remove flood waters consistent with the laws of the state of Washington. The boundaries for such a proposed Hylebos Flood Control Zone District are described in exhibit #1 attached hereto.

1 BE IT FURTHER MOVED, a public hearing to consider the  
2 creation of the proposed Hylebos Flood Control Zone District  
3 shall be held at 9:30 A.M., on the 6<sup>th</sup> day of May,  
4 1974 in the Council Chambers of the King County Council, 4th  
5 Floor, King County Courthouse, Seattle, Washington.

6 The Clerk of the Council is hereby directed to give notice  
7 of such hearing and publish the same in the manner provided in  
8 RCW 36.32.120 (7).
