A MOTION authorizing King County to convey to the City of Bellevue lands which lie within the R/W for the Lake Hills connector, known as the East Governmental Center Site, and declaring Council intent that the consideration for the conveyance shall be applied to the account for the development of the East Governmental Center site.

MOTION NO.

WHEREAS, King County, State of Washington, owns certain lands situated in the City of Bellevue, County of King, State of Washington known as a portion of the East Governmental Center Site, and

WHEREAS, a portion of the East Governmental Site owned by
King County falls within the right of way for the City of Bellevue
Lake Hills Connector Urban Arterial Project, and

WHEREAS, it has become necessary to convey and/or grant to the City of Bellevue the lands which lie within the proposed right of way, together with the necessary easements for right of way slopes and construction permits, and

WHEREAS, it has been determined that Sixty Four Thousand Seven Hundred and Fifty Seven Dollars (\$64,757.00) is a fair and equitable consideration for the conveyance to the City of Bellevue for the right of way, together with slope easements, construction permits and severance and all other damages of whatsoever kind or nature to the remainder of the East Governmental Center Site by reason of the location, construction, operation and maintenance of said right of way, and

WHEREAS, the King County Council has determined that said lands are surplus, and that it is in the best interest of the citizens of King County and the City of Bellevue to convey to the City of Bellevue that portion of the East Governmental Center Site which falls within the proposed right of way of the Lake Hills Connector Urban Arterial Project, being described in "Exhibit A", attached hereto, (and made a part hereof as if the same had been set forth herein),

NOW. THEREFORE, BE IT MOVED that the Council of King County: 1 Having determined that said land is surplus and that it is 2 necessary to convey to the City of Bellevue the required right of 3 way above mentioned, does hereby authorize the County Executive to execute the instruments in favor of the City of Bellevue, a 5 municipal corporation of the State of Washington, necessary for 6 the City of Bellevue to acquire said right of way for the Lake 7 8 Hills Connector Urban Arterial Project, all as described in "Exhibit A", (attached hereto and made a part hereof as if the 9 same had been set forth herein). 10 FURTHER, it is the intent of the King County Council that the 11 12 consideration received for the conveyance of this land to the City of Bellevue be applied to the account for the development of 13 the East Governmental Center Site. 14 The County Executive is requested to submit an ordinance 15 appropriating these funds in support of an Eastside Governmental 16 Center. 17 PASSED this 5th day of August, 1974. 18 19 KING COUNTY COUNCIL
