WHEREAS, the city of Bellevue desires to contract with

King County to obtain the services of the King County Zoning and

A MOTION authorizing the King County Executive to enter into a contract with the city of

Bellevue to provide services by the King County

Subdivision Examiner in hearing proposed planned unit development and planned residential development applications made within the city of Bellevue, and

WHEREAS, the city of Bellevue agrees to pay King County for such services and to provide certain staff assistance,

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- 1. The King County Executive is hereby authorized to sign a contract with the city of Bellevue for the provision of services by the King County Zoning and Subdivision Examiner or the deputy examiner to hear, enter findings of fact and issue a decision in all Bellevue planned unit developments and planned residential unit development cases scheduled before them;
- 2. Such contract with the city of Bellevue shall provide that the county be paid \$200.00 for each case scheduled before the examiner and such contract shall be in substantially the form of the attached intergovernmental agreement which by this reference is incorporated as part of this motion.

## INTERGOVERNMENTAL AGREEMENT

of October, 1974, by and between King County, a municipal corporation and charter county, hereinafter called the "County," and the City of Bellevue, a municipal corporation, hereinafter called the "City":

## WITNESSETH:

That in consideration of the agreement hereinafter set forth the said City does hereby agree to pay to the County Two Hundred Dollars (\$200.00) for each proposed planned unit development (PUD) and for each proposed planned residential unit development (PRUD) scheduled by the City Planning Department to be heard by the King County Zoning and Subdivision Examiner or the deputy Examiner (hereinafter such persons are referred to as the "Examiner"). The total of such payments shall not exceed \$3,000.00.

For said payment the County agrees to perform the following services for the City, to-wit:

- 1. Provide the services of its Examiner for the remainder of 1974 and for 1975 to:
  - (a) hear, enter findings of fact and issue a decision in all City PUD and PRUD cases scheduled before him, total not to exceed fifteen (15) cases, based upon the applicable policies and ordinances of the City;
  - (b) hear all said cases at a location to be provided by the City at a time and date mutually acceptable to the City and the Examiner;
  - (c) attend once each month a meeting of the City Council to explain the PUD and PRUD decisions;
- 2. Provide the Examiner's own secretarial services and office space.

For said services, the City agrees to perform the following, to-wit:

- 1. Provide Legal advice upon request pertaining to such hearings before said Examiner.
- 2. Post and advertise scheduled hearings in conformance with legal requirements.
- 3. Provide Planning Department reports and environmental assessments.
