A MOTION authorizing the County Executive to reprogram funds in the amount of \$400,127 under Title II of the Comprehensive Employment and Training Act, as amended

WHEREAS, the Comprehensive Employment and Training Act of 1973, as amended, provides for the award of grants by the United States Department of Labor, and

WHEREAS, underruns of appropriated funds have occurred through attrition and late hiring, and

WHEREAS, the County Council recognizes the need to reprogram these savings to support a public service employment program for the unemployed citizens of this County,

NOW THEREFORE, BE IT MOVED by the Council of King County:

1. The King County Executive is hereby authorized and directed to reprogram funds in the amount of \$400,127 for positions as detailed in the attached list;

2. The King County Executive is hereby authorized and directed to file and execute such documents as are required by the Department of Labor for the reprogramming of such funds;

3. The Federal/State Relations Division is hereby named the authorized correspondent for King County and is further authorized to furnish such additional information and documents as may be required;

4. The United States of America, Department of Labor, and the State of Washington are hereby assured full compliance with Title IV of the Civil Rights Act of 1964.
