

MOTION NO. 202375-330

1 A MOTION authorizing the County Executive to
2 execute and submit applications to the State
of Washington and the Federal Government for
funds to support the construction of a proposed
North Health District Facility, File No. 541

3 WHEREAS, the State of Washington has funds available under
4 Rederendum 29 for the award of grants through the Department of
5 Social & Health Services, and

6 WHEREAS, the Federal Government under the Public Health
7 Services Act (Hill-Burton program) provides for the availability
8 of funds for the award of grants and loans through the Department
9 of Health, Education and Welfare, and

10 WHEREAS, other public agencies may provide funds for the award
11 of grants and loans, and

12 WHEREAS, the King County Council recognizes the need for the
13 construction of an improved North Health District Facility, and

14 WHEREAS, the King County Council finds that a North Health
15 District Facility will provide benefits to the public in the
16 form of improved accessibility and delivery of public health
17 services.

18 NOW, THEREFORE, BE IT MOVED by the Council of King County:

19 1. The County Executive is hereby authorized to make appli-
20 cations to the State of Washington for funds in the approximate
21 amount of \$2,062,500 or such lesser amount having regard to the
22 possible options as may be appropriate on behalf of King County;

23 2. The County Executive is hereby authorized to make appli-
24 cations to the Federal Government for funds in the approximate
25 amount of \$540,000 or such lesser amount having regard to the
26 possible options as may be appropriate on behalf of King County;

27 3. The County Executive is hereby authorized to make
28 applications to such other public agencies that may have funds
29 available to support construction of a North Health District
30 Facility and the County Executive is required to notify in writing
31 the Chairman of the County Council of the amount of funds and the
32 agency to which such application is made;

1 4. The County Executive is hereby authorized and directed
2 to file and execute such applications and contracts as are re-
3 quired by the State or Federal Governments;

4 5. The Federal/State Relations Division is named the
5 authorized correspondent for King County and is further authorized
6 to furnish such additional information and documents as may be
7 required by the State or Federal Government;

8 6. The United States of America, Department of Justice, and
9 the State of Washington are hereby assured full compliance with
10 Title VI of the Civil Rights Act of 1964.
