A MOTION authorizing the County Executive to execute and submit a grant application to the Department of Health, Education and Welfare, Alcohol, Drug Abuse and Mental Health Administration for funds in the amount of \$1,253,886 to support the Center for Addiction Services Project, Grant File No. 605.

WHEREAS, the Department of Health, Education and Welfare, Alcohol, Drug Abuse and Mental Health Administration provides for the award of grants to provide valid alternatives to incarceration for the serious drug user through a wide range of individualized programs; funds to develop and facilitate a comprehensive, cohesive program through existing agencies; to provide diagnostic detoxification, methadone maintenance and residential services as well as outpatient counseling, referral, and follow-up services to facilitate rehabilitation, and

WHEREAS, the county recognizes its obligation to provide, as support to this program, \$12,500 as a local cash match, and

WHEREAS, it is the intent of the Council to make clear to all parties that the approval of a grant application, including authorizing the Executive to submit an application for funds to the funding source, does not suffice, by itself, as a legal or legislative mandate by which administrative organizations may take action, and

WHEREAS, it is the intent of the Council that if authority for specific administrative activities does not exist by virtue of ordinances or statutes, then those administrative activities shall not be allowed without formal clarification, by legislative action, of the authority of the administrative organizations.

NOW THEREFORE, BE IT MOVED by the Council of King County:

1. The King County Executive is hereby authorized to make application for funds in the amount of \$1,253,866 to the Department of Health, Education and Welfare, Alcohol, Drug Abuse

1 and Mental Health Administration, on behalf of King County.

2 2. The County Executive is hereby authorized to file and
3 execute such applications and correspondence as is necessary and
4 required by the federal government to secure available funds.

5 3. The United States of America, Department of Health,
6 Education and Welfare, Alcohol, Drug Abuse and Mental Health
7 Administration, and the State of Washington are hereby assured
8 full compliance with Title VI of the Civil Rights Act of 1964.

9 4. The Council reserves the right, based on Executive
10 recommendation, to submit formal amendments to the funding source
11 should, based on Executive and Council review, more efficient
12 methods of operation and administration be implemented that will
13 result in more effective direct service to the community.

14 5. The Council intends that no funds shall be appropriated
15 to support this function after July 1, 1976, unless the Executive
16 as part of an appropriation process addresses the following
17 issues in formal review to include, as applicable, amendatory
18 legislation.

19 a. Identification of benefits and cost savings to the
20 county and the community under the proposed management structure
21 contained in the CAS application.

22 b. Identification of the process, with time frames as
23 applicable, by which benefits and cost savings will be realized.


24 c. Identification of the future role of CAS and the Division
25 of Human Services in managing the federal grant and subcontractor
26 agreements.

1 d. Identification of the process, with time frames as
2 applicable, by which the management functions of CAS and the
3 Division of Human Services will be substantially altered as a
4 result of administering the federal grant.


