A MOTION relating to the conveyance of County road right of way to the State of Washington, 415th S.E. (SR90, Echo Lake Interchange to Tanner).

WHEREAS, King County is the record owner of County road right of way described as that portion of 415th S.E., being in the NE 1/4 of the SW 1/4 of Section 9, Township 23 North, Range 8 East, W.M. and bounded by Relocated South Fork Road on the northwest and Relocated 415th S.E. on the south, and
