MOTION NO. 2811

A MOTION authorizing the County Executive to grant an easement in favor of Water District 104, across Sammamish River Park #83, near Woodinville.

WHEREAS, Water District 104 has made plans to install and maintain a 12" water pipeline with connections, manholes, and appurtenances on certain lands owned by King County, and located in Sammamish River Park #83, and

WHEREAS, Water District 104 has bargained for a perpetual easement over, across, along, in, upon, and under the aforementioned County lands to be conveyed to Water District 104 for the purpose of installing and maintaining a water pipeline with connections, manholes and appurtenances, and

WHEREAS, the King County Council has determined it to be necessary and in the best interests of the citizens of King County that the said easement be granted in and for the consideration of mutual benefits,

NOW THEREFORE, BE IT MOVED by the Council of King County:
The County Executive is hereby authorized to sign and deliver the necessary water pipeline easement, granting to Water
District 104 an easement over, across, along, in, upon, and
under County owned property situated in King County and more
particularly described as follows:

A water line easement situated in the SW 1/4 of the NE 1/4 of Sec. 9, Twp 26 N., Rge 5 E., W.M., in King County, Washington, lying 5 feet left and 5 feet right of the following described centerline:

Commencing at the N.W. corner of the SW 1/4 of the NE 1/4 of said Sec. 9 and running So. 01°25'16" West 164.10 ft. to the Sly right of way line of State Sign Route #522; thence running So. 79°19'51" East along said Sly right of way line 484.29 ft. to the point of beginning of said easement; thence running So. 10°40'09" West 102.65 ft.; thence running Southeasterly along a curve concave Southwesterly, said curve having a central angle of 08°33'33" a radius of 456.60 ft., an arc length of 68.21 ft. and a chord bearing and distance of So. 41°02'54" East 68.15 ft.; thence running So. 36°46'08" East 184.78 ft.; thence running Southeasterly along a curve concave Northwesterly, said curve having a central angle of 14°57'02", a radius of 799.90 ft., an arc length of 208.72 ft. and a chord bearing and distance of So. 44°14'39" East, 208.13 ft. to the Northeasterly projection of the following described property line.

Commencing at a point on the South line of the SW 1/4 of the NE 1/4 of said Sec. 9, South 88°34'22" East, 1 504.00 feet from the S.W. corner thereof, being an 2 intersection with the centerline of Northern Pacific Railway; thence running North 53°48'19" West along said centerline 142.1 feet; thence running North 36° 3 11'41" East 95.00 feet to the Point of Beginning of the said property line; thence continuing North 36° 11'41" East 466.40 feet, more or less, to the center-line of the old channel of Sammamish River and the 5 end of said property line; 6 Thence running South 36°11'41" West along said North-7 easterly projection of property line 155.74 feet, more or less, to the centerline of the old Sammamish River channel and the end of easement centerline. 8 9. TOGETHER WITH a temporary construction easement lying 10 20 feet right of the above described centerline.
