A MOTION approving the 1977 King County Plan for Drug Abuse Services and authorizing the County Executive to transmit the Plan to the State of Washington, Department of Social and Health Services.

WHEREAS, State grant-in-aid funds are provided to King
County to offer a meaningful program of rehabilitation for those
persons suffering from problems related to narcotic drugs,
dangerous drugs, and

WHEREAS, the receipt of state funds is contingent upon DSHS review and approval of an annual plan of services prepared and submitted by King County to the state of Washington, and

WHEREAS, the timely submittal of the 1977 King County Plan for Drug Abuse Services to DSHS is required to insure that funding to subcontracting community based organizations is not impaired, and

WHEREAS, the use of state funds is combined with federal grant-in-aid moneys to form the total amount of resources allocated by King County to fund a comprehensive service network to combat drug abuse problems, and

WHEREAS, the drug abuse program in King County is currently the subject of two independent audits by both King County and the federal funding source, and

WHEREAS, the effectiveness and cost-efficiency of the present system of service delivery has been and continues to be an issue of policy with the Council, and

WHEREAS, the use of state funds is intertwined with proposed program operations which will be before the Council for review in the form of the Center For Addiction Services (CAS) annual refunding application to the rederal government in mid-February, 1977, and

WHEREAS, information currently being prepared for Council review as part of the review of the CAS annual refunding application may or may not result in major revisions to the current

- The conclusions of the CAS annual refunding application review by the Council, of which state funds are an integral financial component.
