The people named on the lists attached to this motion as County Executive appointments to the Agricultural District Advisory Committees specified in Ordinance 3074 are hereby confirmed.

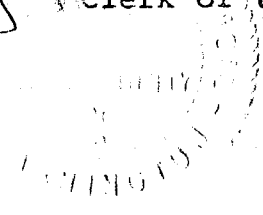
