2 A MOTION amending King County Motion 2766 and
3 authorizing an amendment to the contract
4 between King County and the City of Seattle
5 for the transfer of land for the North
6 District Office of the Seattle-King County
7 Department of Public Health.

8 WHEREAS, King County and the City of Seattle pursuant to
9 RCW 70.08 operate a combined Seattle-King County Department of
10 Public Health, and

11 WHEREAS, King County is acting as the applicant to secure
12 both state and federal funds for the construction of a North
13 District Office and Multiservice Center, and

14 WHEREAS, the City of Seattle desires to transfer to King
15 County the real property described in the warranty deed, attached
16 hereto as Exhibit A, for the site of the North District Office
17 and Multiservice Center, and

18 WHEREAS, the City of Seattle pursuant to Ordinance 105986
19 and King County pursuant to Motion 2766 did execute a Contract
20 for Transfer of Land on November 30, 1976, and

21 WHEREAS, the State of Washington has requested an amendment
22 to Condition One of said Contract for Transfer of Land, and the
23 City of Seattle by Ordinance 106249 has authorized said
24 amendment and its inclusion in the warranty deed attached hereto;

25 NOW THEREFORE, BE IT MOVED by the Council of King County:

26 The following amendment to Condition One of the Contract for
27 Transfer of Land executed by the parties on November 30, 1976,
28 pursuant to City of Seattle Ordinance 105986 and King County
29 Motion 2766, is hereby authorized:

30 That the property herein conveyed be developed and
31 improved and thereafter operated and maintained as a
32 North End Multiservice Center for the purpose of
33 providing social and health service facilities
including without limitation: social services, adult
and juvenile correction or detention facilities, child
welfare, daycare, drug abuse and alcoholism treatment,
mental health, public health, developmental
disabilities and vocational rehabilitation; all as

1 contemplated by RCW 43.83(D).010 and more particularly
2 described in RCW 43.83(D).050, but in any event a
3 North District Office for the Seattle-King County
4 Department of Public Health, for a period not less than
5 twenty-five (25) years.
