MOTION NO. C3380

2 A MOTION adopting the 1978 Housing Assistance
3 Plan, and authorizing the County Executive to
4 submit the Plan with the Fourth Year Housing
5 and Community Development Block Grant
6 Application to the Department of Housing and
7 Urban Development.

8 WHEREAS, The Housing and Community Development Act of 1974,
9 as amended, establishes a program of financial assistance to
10 local governments for the development of viable urban communities
11 through the provision of decent housing and a suitable living
12 environment and expanded economic opportunities, primarily for
13 persons of low and moderate income; and,

14 WHEREAS, the Act provides that the Housing Assistance Plan
15 is the focus for mutual cooperation between local jurisdictions
16 and national HUD housing programs for carrying out locally
17 determined housing strategies; and,

18 WHEREAS, King County qualifies as an "urban county" under
19 the provisions of the Act; and,

20 WHEREAS, King County is in a Consortium with twenty-five
21 cities and towns; and,

22 WHEREAS, the Joint Policy Committee has reviewed and
23 approved the Housing Assistance Plan, required by federal law to
24 be submitted as part of the Block Grant application; and,

25 WHEREAS, the Council had held public hearings to hear the
26 views of citizens on housing and community development needs;

27 NOW THEREFORE, BE IT MOVED by the Council of King County:

28 The 1978 Housing Assistance Plan is adopted as part of the
29 overall Community Development Plan and Application.

30 BE IT FURTHER MOVED:

31 1. The Council of King County finds and determines that
32 this Housing Assistance Plan reflects the needs and priorities
33 for housing assistance in King County and that it shall supersede
the 1977 Housing Assistance Plan immediately upon adoption by the
Council and approval by HUD, except that the 1977 Housing

1 Assistance Plan Current Year Goals shall remain in effect until
2 June 30, 1978.


3 2. The King County Executive is hereby authorized to submit
4 the 1978 Housing Assistance Plan to the Department of Housing and
5 Urban Development with the County's application for Housing and
6 Community Development block grant funds.

7 3. The King County Executive is also authorized to utilize
8 this Housing Assistance Plan in reviewing and ranking projects
9 proposed for federal housing assistance under Section 213 of the
10 Housing and Community Development Act of 1974, as amended.


11 4. It is the County's intention that federal housing
12 agencies comply with both the spirit and the letter of the goals
13 and priorities stated in this Housing Assistance Plan when making
14 program allocations and conducting other activities in the
15 County.
