## MOTION NO. 03433

A MOTION establishing a Vashon Communities Plan Committee and establishing the responsibilities of the Community Plan Committee and the King County Planning Division in developing a Vashon Communities Plan and approving the appointment of citizens to serve on the Vashon Community Plan Committee.

WHEREAS, a Community Plan for Vashon Island has previously been scheduled to commence in 1978, and

WHEREAS, the Vashon Island community has done considerable preliminary work to identify community concerns and priorities, and

WHEREAS, preliminary study has been initiated by the Planning Division on the Vashon Communities Plan, and

WHEREAS, a Communities Plan when adopted by the County

Council represents the official development and capital improvement program policy for a community, and

WHEREAS, a Communities Plan provides the link between general county-wide policies, plans and programs and specific implementation programs for a community, and

WHEREAS, a Communities Plan is intended to be utilized by other governmental agencies when making decisions concerning community development,

WHEREAS, the King County Executive and the Councilperson from District No. 7 have recommended ten members and two alternates each to the Vashon Communities Plan Committee per Motion No. 2946.

NOW THEREFORE, BE IT MOVED by the Council of King County:

There is hereby established a twenty-one member Vashon

Communities Plan Committee to be appointed as follows:

- 1. Ten (10) members and two (2) alternates to be appointed by the Councilperson from District No. 7;
- 2. Ten (10) members and two (2) alternates to be appointed by the County Executive and
  - 3. A chairperson appointed by the Chairperson of the Policy

 Development Commission.

- 4. Alternatives are to serve in the event a member is unable to complete his or her term, and additional alternates, if needed, are to be appointed by the original appointer of the member leaving the Committee, and approved by the Council.
- 5. All Committee members and alternates shall be subject to the disclosure provisions of K.C.C. 3.04.050.
- 6. Alternates shall assume committee membership based on the closest geographic proximity to the member resigning.

BE IT FURTHER MOVED by the Council of King County:

The Vashon Communities Plan Committee shall:

- 1. Be responsible for developing the Vashon Community
  Involvement Process and executing the program with the assistance
  of the Community Involvement Coordinator assigned to the Community
  Plan by the Policy Development Commission.
- 2. Assist the Planning Division in developing proposed policies, programs and map alternatives for the community that are consistent with the Comprehensive Plan and other standards and official controls enacted by the County Council. Proposed policies, programs or map alternatives in the Community Plan that are not consistent with the Comprehensive Plan and other standards and official controls enacted by the County Council should be presented as recommended amendments to adopted County policies.
- 3. Recommend a Community Plan to the Council and Executive along with any alternatives the Committee or the Planning Division may wish to include,

BE IT FURTHER MOVED by the Council of King County:
The Planning Division shall:

1. Prepare preliminary community profiles to include an inventory and analysis of the environment, population growth, land use, transportation, utilities, recreation, public facilities and services and compile existing plans and policies applicable to the area.

2. Prepare for review proposed policies, programs, and map alternatives.

- 3. Advise the Committee of possible impacts of proposed policies, programs and map alternatives and identify any inconsistent or unimplementable policies, programs and map alternatives under consideration.
- 4. Prepare preliminary and final Community Plan documents and Environmental Impact Statements.

BE IT FURTHER MOVED by the Council of King County:

- 1. The scope of the Vashon Communities Plan shall be concerned with areas of land use distribution and densities, transportation networks, open space and recreation facilities, sewer and water service areas, allocation of \$75,000 in 1978 Housing and Community Development Block Grant funds for Vashon, and related capital improvement programs planned for implementation in the next six to twelve years.
- 2. Said attached list of members of the Vashon Communities
  Plan Committee is approved as presented.
- 3. The schedule for completion of the Vashon Communities Plan will be as follows:
  - a) June 30, 1978: Allocation of \$75,000 in 1978

    Housing and Community Development Block Grant funds
    determined;
  - b) September 14, 1978: Community Profiles completed and presented to the community;
  - c) February 28, 1979: Preliminary Draft Plan completed and presented to the community;
  - d) May 30, 1979: Final draft plan completed and transmitted to the Council.
