2 A MOTION authorizing the County Executive to
3 enter into a contract with Puget Sound Power
4 and Light Company for a franchise to con-
5 struct, maintain and operate electric trans-
6 mission and distribution lines; and consoli-
7 dating Franchises 38, 49, 66, 92, 119, 199,
8 212, 250, 311, 340, 353, 372, and 381 and
9 adding other King County roads.

10 WHEREAS, Puget Sound Power and Light is desirous of consoli-
11 dating thirteen of its previously separate and existing franchises
12 in King County under one franchise contract, and

13 WHEREAS, Puget Sound Power and Light is desirous of adding
14 King County roads not covered by other of its existing franchises
15 to said contract, and

16 WHEREAS, Puget Sound Power and Light, as provided by RCW
17 36.55.010 of the State of Washington, has properly filed an
18 application for a franchise to construct, maintain and operate
19 electric transmission and distribution lines, and

20 WHEREAS, the application has been referred to the County
21 Executive for investigation of the feasibility thereof and the
22 checking of plans and description of the location thereof, and

23 WHEREAS, the County Executive has recommended approval of
24 said franchise.

25 NOW THEREFORE, BE IT MOVED by the Council of King County:

26 The County Executive is hereby authorized to enter into and
27 execute the attached electric transmission and distribution line
28 franchise contract, consolidating franchises 38, 49, 66, 92, 119,
29 199, 212, 250, 311, 340, 353, 372, and 381, and adding King
30 County roads not covered by other existing Puget Sound Power
31 and Light franchises, for Puget Sound Power and Light Company,
32 which by reference are incorporated herein as part of the Motion.
33 Said Franchise is granted to Puget Sound Power and Light Company
for the term of twenty-five years, and includes a legal descrip-
tion of the location and all of the general conditions required
by the County.
