

MOTION NO. 4077

2 A MOTION adopting the 1979-80 Housing Assistance  
3 Plan, and authorizing the County Executive to  
4 submit the Plan with the Fifth Year Housing and  
Community Development Block Grant Application to  
the Department of Housing and Urban Development.

5 WHEREAS, the Housing and Community Development Act of 1974,  
6 as amended, establishes a program of financial assistance to local  
7 governments for the development of viable urban communities through the  
8 provision of decent housing and a suitable living environment and expanded  
9 economic opportunities, primarily for persons of low and moderate income;  
10 and,

11 WHEREAS, the Act provides that the Housing Assistance Plan is  
12 the focus for mutual cooperation between local jurisdictions and national  
13 HUD housing programs for carrying out locally determined housing strategies;  
14 and,

15 WHEREAS, King County is in a Consortium with twenty-six cities  
16 and towns; and,

17 WHEREAS, the Joint Policy Committee has reviewed and approved  
18 the Housing Assistance Plan, required by federal law to be submitted as  
19 part of the Block Grant application; and

20 WHEREAS, the Council had held public hearings to hear the views  
21 of citizens on housing and community development needs; and

22 WHEREAS, the King County Housing Task Force made recommendations  
23 incorporated in the 1979-80 Housing Assistance Plan;

24 NOW THEREFORE, BE IT MOVED by the Council of King County:

25 The 1979-80 Housing Assistance Plan is adopted as part of the  
26 overall Community Development Plan and Application.

27 BE IT FURTHER MOVED:

28 1. The Council of King County finds and determines that this  
29 Housing Assistance Plan reflects the needs and priorities for housing  
30 assistance in King County and that it shall supersede the 1978 Housing  
31 Assistance Plan after adoption by the Council and approval by HUD,  
32 effective October 1, 1979.

33 2. The King County Executive is authorized to amend the

1978 Housing Assistance Plan to include revised assisted housing criteria, and the map for general locations for new assisted housing, effective immediately upon adoption by the Council.

3. The King County Executive is hereby authorized to submit the 1979-80 Housing Assistance Plan to the Department of Housing and Urban Development with the County's application for Housing and Community Development block grant funds.

4. The King County Executive is also authorized to use this Housing Assistance Plan in reviewing and ranking projects proposed for federal housing assistance under Section 213 of the Housing and Community Development Act of 1974, as amended.

5. It is the County's intention that federal housing agencies comply with both the spirit and the letter of the goals and priorities stated in this Housing Assistance Plan when making program allocations and conducting other activities in the County.
