WHEREAS, the Auburn Arts Council has contributed \$35,000 in cash and services as the matching amount required by WAC 82.40.010-070, which governs Referendum 28 grants, and

WHEREAS, the Neely Mansion is located in unincorporated King County and WAC 82.40.010-070 requires that projects of private, non-profit corporations be co-sponsored by local government, and

WHEREAS, King County and the Auburn Arts Council mutually desire that the Neely Mansion be restored and maintained as an historic landmark, and

WHEREAS, the County and the State of Washington have determined that the proposed Project Agreement for the acquisition and restoration of the Neely Mansion is consistent with the purposes of Referendum 28 and the Comprehensive Plan, Ordinance 2991, KCC 20.12.015.
