MOTION NO.

A MOTION granting the appeal of ALAN M. MOSER and reclassifying the property petitioned in Building and Land Development File No. 224-79-R from SR to RM 900, subject to a Planned Unit Development.

WHEREAS, the Zoning and Subdivision Examiner, by report dated May 23, 1979 has recommended that the property subject to the application of ALAN M. MOSER, designated Building and Land Development File No. 224-79-R, be reclassified from SR to RM 1800, in lieu of RM 900, subject to a Planned Unit Development, and WHEREAS, the Examiner's recommendation has been appealed by

WHEREAS, the Council has reviewed the record and the written appeal arguments, and

WHEREAS, the Council concurs with, and adopts as its own, the Examiner's findings and conclusions, except Conclusion No. 3 on page 7 of his report, and

WHEREAS, the Council finds that the Examiner erred in concluding that the RM 1800 classification would be more appropriate for this site than the RM 900 classification, and

WHEREAS, the Council concludes that the property should be reclassified to RM 900, provided it is subject to a planned unit development as set forth in the Examiner's recommendation,

NOW THEREFORE, BE IT MOVED by the Council of King County:

The reclassification from SR to RM 900 petitioned by ALAN M. MOSER under Building and Land Development File No. 224-79-R is approved subject to the following pre-ordinance conditions:

- 1. The property owner shall obtain approval of a preliminary planned unit development in accordance with the provisions of Chapter 21.56 King County Code within twenty-four months from the date of Council action on this application.
- 2. The applicant shall obtain approval of final planned unit development plans in accordance with the provisions of Chapter 21,56 King County Code. The proposed ordinance for this reclassification and the proposed ordinance for the final planned unit development shall be transmitted to the Council for action at the same time.
