A MOTION authorizing the County Executive to grant an easement to Puget Sound Power and Light Company at Vashon Nike Site for electrical power lines in County District No. 7.

WHEREAS, the sumplus U.S. Army Nike Launching Site on S.W. 220th Street, Vashon, Washington, has been transferred to the King County Parks Department, and

WHEREAS, the Vashon Junior Chamber of Commerce is to develop the site for community recreation and park use, and

WHEREAS, the Vashon Junior Chamber of Commerce has requested Puget Power service for the barracks, well site, automotive shop and a maintenance building, and

WHEREAS, Puget Power is willing to assume ownership of the existing primary overhead system and provide the requested service if King County will provide Puget Power an unconditional release of interest covering all the existing overhead primary distribution system and provide Puget Power a ten foot easement with rights of extension along the existing pole line.

NOW THEREFORE, BE IT MOVED by the Council of King County:

The County Executive is hereby authorized to sign and deliver the necessary instrument to Puget Power conveying to Puget Power the existing overhead primary distribution system and granting Puget Power an easement over, across, along, in, upon and under County owned property situated in King County described as follows:

A portion of the W 1/2 of the NE 1/4 of the SE 1/4 of Section 12, Township 22 North, Range 2 East, W.M., lying Ely of a line beginning at a point 165 feet West of the NE corner of said subdivision; thence South 0°18' West 52.61 feet; thence South 19°47' West 334.63 feet; thence South 01°13' West 638.82 feet to the South line of said subdivison and terminus of this line.

Grantee shall only have rights upon that portion of property (the 'Right of Way' herein) described as follows:

A strip of land 10 feet in width, five on either side of the following described centerline:

Beginning at a point 189.22 feet West of the SE corner of the W 1/2 of the NE 1/4 of the SE 1/4 of Section 12, Township 22 North, Range 2, East, W.M., thence North 2953 101 West along an
