A MOTION adopting the Master Plan for North Sea-Tac Park in concept

WHEREAS, King County and the Port of Seattle jointly undertook the North Sea-Tac Park Master Plan Study to explore recreation opportunities on noise-impacted land either acquired or scheduled for acquisition directly north of Sea-Tac International Airport in Southwest King County by the Port of Seattle, and

WHEREAS, the Sea-Tac Community Plan made recommendation for open space and recreation use of such noise impacted land, and

WHEREAS, the proposed Master Plan for the North Sea-Tac Park has been endorsed by the Policy Advisory Committee for the Sea-Tac Community Plan, and

WHEREAS, the proposed Master Plan for the North Sea-Tac Park has been endorsed by the Highline Recreation Council, the Highline Community Council and has had considerable community input, and

WHEREAS, the Commissioners of the Port of Seattle, at their meeting on June 24th, 1980, adopted in concept the Master Plan for the North Sea-Tac Park, and

WHEREAS, it would be desirable to have a guide for directing park and recreation development of these lands by government and/or citizen groups.

NOW THEREFORE BE IT MOVED by the Council of King County:

The Master Plan for North Sea-Tac Park is adopted in concept and shall serve as a guide for the utilization of those noise impacted lands owned by the Port of Seattle directly north of Seattle-Tacoma International Airport.

BE IT FURTHER MOVED by the Council of King County:

Implementation of this Master Plan shall be accomplished with the advise of Highline area citizen groups, including but not limited to, the Highline Recreation Council, Highline Community Council, Highline Soccer Association, Little League, Burien Bearcats, Boys Clubs, and residents within immediate proximity to North Sea Tac Park. A North Sea Tac Park Advisory Committee shall be constituted, with membership from the entities enumerated above and others, to assist the County in updating priorities and development of Park facilities.
