MOTION NO. 5404

A MOTION rescinding Motion 5133, and establishing and defining the composition and functions of the committees of the King County Council.

WHEREAS, the interests of the citizens of King County and the efficiency of the operations of the County Council are best served by apportioning the duties and responsibilities of the council among several committees,

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- Motion No. 5133 is hereby rescinded.
- The council may go into committee-of-the-whole at any time. Committee functions shall be to consider subjects of general interest including council personnel; budget review; appointments to boards and commissions; and reports from the executive branch.
- C. The chairman of the council shall appoint the chairman, vice-chairman and the membership of the standing committees, with consent of a majority of the council members.

The standing committees are established as follows:

HEALTH, HOUSING AND HUMAN SERVICES - NO MORE THAN FOUR MEMBERS.

Function: To consider and make recommendations on matters relating to health, housing, welfare and human resource programs This shall include but is not limited to human of the county. services functional planning and programming, particularly as it relates to the Housing Authority of King County, the Housing and Community Development Block Grant, housing assistance programs and housing rehabilitation policies.

PLANNING AND COMMUNITY DEVELOPMENT - NO MORE THAN THREE MEMBERS.

Function: To consider and make recommendations on community plans and land use matters which implement comprehensive planning such as area rezones, housing, parks and recreation,

zoning code revision and shoreline management.

3. FISCAL MANAGEMENT - NO MORE THAN SIX MEMBERS.

Function: To recommend budget objectives and priorities and to evaluate the yearly executive budget proposal; to consider and make recommendations on matters and legislation of a fiscal nature, including appropriations, expenditures, the selling of bonds and investment policies, and on matters relating to the levying of taxes; to investigate and report on financial claims filed against the county; and to examine requests for changes in assessments and taxes.

4. AUDIT - NO MORE THAN FOUR MEMBERS.

Function: To receive and examine reports of the county and state auditor and submit such recommendations to the county council as it deems necessary or desirable in connection with the subject matter of such reports; coordinate council overview of the economy, efficiency and effectiveness of all county departments and programs; and to review proposed work programs of the county auditor and make recommendations thereon to the county council.

5. GROWTH MANAGEMENT - NO MORE THAN THREE MEMBERS.

Function: To consider and make recommendations on matters pertaining to countywide comprehensive planning for land use and service delivery; and long-range planning for open space, agriculture, water quality, water resources, transportation, flood control and surface water management.

6. OPERATIONS, POLICE AND JUDICIARY - NO MORE THAN FIVE MEMBERS.

Function: To consider and make recommendations on matters relating to county personnel, records and elections, amendment of the county charter, the criminal justice system, including law, safety and justice, functional planning and programming, and to oversee and receive reports from the office

FACILITIES AND ECONOMIC DEVELOPMENT - NO MORE THAN FOUR MEMBERS.

Function: To consider matters relating to programs to promote economic growth, resource management and community development and employment. To act as liaison with public and private agencies, groups and organizations intended to enhance economic growth, including council relations with the Port of Seattle, the Economic Development District, the Economic Development Council and the State Department of Commerce and Economic Development.

Matters relating to public utilities and facilities; more specifically, the establishment, vacation, construction and maintenance of streets and roads; trails, park properties and facilities; solid waste disposal; surface water management; building permits, codes and fees; fire hydrant and water pressure standards, cable television regulations and fees and energy implementation policies.

8. INTER-GOVERNMENTAL RELATIONS - NO MORE THAN FOUR MEMBERS:

To consider and make recommendations on Function: matters of joint interest between the county and a other counties, the state of Washington and the federal government, b. the city of Seattle and other towns and municipalities within the county, and c. other government agencies such as Metro and the Puget Sound Council of Governments.

LAND USE APPEALS - NINE MEMBERS.

Function: To consider and report upon appeals from recommendations of the office of Zoning and Subdivision Examiner.

> 10. PERSONNEL - NO MORE THAN THREE MEMBERS.

Function: To consider and make recommendations on matters relating to the employment, performance, utilization and compensaindividuals comprising the stuff of the King County Council.

D. The date and time of standing committee meetings shall be determined by the chairman of each such committee. At least one day prior to the meeting, an agenda shall be posted outside the council chambers and shall include the time and place of the committee meeting. Any member of the council present at a meeting of any standing committee, though not a member thereof, shall be entitled to participate in the deliberations of such committee, but shall not be entitled to vote therein unless designated a member pro tem by the committee chairman.

E. In order for a proposed ordinance or motion to be reported out by a standing committee, a majority of the membership of that committee must sign a majority recommendation.

The majority recommendation of the committee may be "do pass",

"do pass as amended", "do pass attached substitute", "do not pass",

"no recommendation", "postpone indefinitely", or "withdraw".

Minority reports may also be submitted by one or more members of the committee.

F. The committee chairman has the option of declaring no quorum or selecting another councilmember to serve on the committee as a member pro tem, if in need of a quorum, In the absence of the chairman and vice-chairman of a committee, a committee member, designated by the committee chairman, may serve as chairman of the meeting.
