A MOTION authorizing the County Executive to make a grant application for funds in the approximate amount of \$720,000 to support improvements to the West Taxiway at the Boeing Field/King County International Airport, Grant File No. 301

WHEREAS, the U. S. Department of Transportation, Federal Aviation Administration is empowered to make grants to support improvement of public airports, and

WHEREAS, the West Taxiway at Boeing Field/King County
International Airport needs resurfacing and additional lighting,
and

WHEREAS, improvements to the West Taxiway will assist the County in meeting the needs of the users of Boeing Field/King County International Airport, and

WHEREAS, the Council recognizes an obligation to provide the amount of \$80,000 as a contribution in support of the project.

NOW, THEREFORE, BE IT MOVED by the Council of King County: .

- A. The King County Executive is hereby authorized to make application for funds in the approximate amount of \$720,000 to the U. S. Department of Transportation, Federal Aviation Administration for the West Taxiway project at Boeing Field/King County International Airport on behalf of King County;
- B. The King County Executive is hereby authorized to file and execute such applications and enter into and execute such contracts as are required by the grantor;
- C. The King County Executive is also authorized to enter into and execute such subcontracts as are necessary for the implementation of the project;
