A MOTION relating to the conveyance of County road rights-of-way to the State of Washington (SR 509), 21st Avenue S.W. to 8th Avenue S.W.).

WHEREAS, King County is the record owner of county roads
lying within the Right-of-Way of state road project SR 509 (21st
Avenue S.W. to 8th Avenue S.W.), and

WHEREAS, in the construction of state road project SR 509 (21st Avenue S.W. to 8th avenue S.W.) by the State of Washington, Department of transportation, it is necessary and advisable for the State of Washington to acquire title to all county road rights-of-way lying within the right-of-way of said highway project, and

WHEREAS, after due consideration, the council of King County deems it necessary and in the best interest of the citizens of King County and of the State of Washington that King County convey said county road rights-of-way that fall within SR 509 from 21st Place S.W. to approximately 16th Avenue S.W. to the State of Washington by Quit Claim Deed for a consideration of mutual benefits.

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The King County Executive is authorized to execute, on behalf of the citizens of King County, the necessary instruments in order to convey the rights-of-way described on the attached Exhibit A and deliver the same to the State of Washington.
