WHEREAS, the council of King County did on the 5th day of March, 1984, approve and adopt an appropriation of \$103,000.00 to Capital Improvement Project No. 070292 by Ordinance No. 6718 for the acquisition of Timberlane Park Site; and

WHEREAS, Ordinance No. 6718 provides for the transfer of the funds from Capital Improvement Project No. 007241, Big Soos Creek Trail, to Capital Improvement Project No. 007292, Timberlane Park in the Park Acquisition and Development Fund, and

WHEREAS, Ordinance No. 6718 did amend and revise the 1984 Capital Improvement Budget and Program, amending Ordinance No. 6597, Section 77, and

WHEREAS, the personal representatives of the estate of Bessie E. Johnson, deceased, has agreed to sell to King County, those lands described herein as TRACT X for the sum of \$205,000.00 payable as follows: \$55,000.00 on date of closing, and the balance payable on or before August 31, 1985, and
