MOTION NO. 6369

A MOTION adopting the 1986-1988 Housing Assistance Plan and the 1986 Annual Action Plan and authorizing the King County Executive to submit the Plans to the United States Department of Housing and Urban Development.

WHEREAS, the Housing and Community Development Act of 1974, as amended, establishes a program of financial assistance to local governments for the development of viable urban communities through the provision of decent housing and a suitable living environment and expanded economic opportunities, primarily for persons of low and moderate income, and,

WHEREAS, the Act provides that the three year Housing Assistance Plan and Annual Action Plan are the focus for mutual cooperation between local jurisdictions and United States Department of Housing and Urban Development (HUD) housing programs for carrying out locally determined housing strategies, and,

WHEREAS, King County is in a consortium with twenty-four cities and towns, and

WHEREAS, the Joint Policy Committee has reviewed and approved the Housing Assistance Plan and the Annual Action Plan, required by federal law to be submitted as part of the community development block grant program, and

WHEREAS, the King County council has held public hearings

1 to hear the views of citizens on housing and community
2 development needs,

3 NOW, THEREFORE, BE IT MOVED by the Council of King County:

4 The 1986-1988 Housing Assistance Plan and 1986 Annual
5 Action Plan are adopted as part of the overall community
6 development program.

7 BE IT FURTHER MOVED:

8 A. The Council of King County finds and determines that
9 this Housing Assistance Plan reflects current conditions for
10 housing assistance in King County.

11 B. The Council of King County finds and determines that
12 this Annual Action Plan reflects the needs and priorities for
13 housing assistance in King County and that it shall supersede
14 the 1985 Annual Action Plan after adoption by the council and
15 approval by HUD.

16 C. The King County executive is hereby authorized to
17 submit the 1986-1988 Housing Assistance Plan and 1986 Annual
18 Action Plan to HUD, provided that the executive shall notify
19 HUD that strategies numbered 2,5, and 7 under 1986 Housing
20 Goals and Strategies, Goal 6 are contingent on future county
21 council budgetary and policy review and decision.

22 D. The King County executive is also authorized to use
23 this Annual Action Plan in reviewing and ranking projects
24 proposed for federal housing assistance under Section 213 of
25 the Housing and Community Development Act of 1974, as amended.

2 agencies comply with both the spirit and the letter of the
3 goals and priorities stated in this Housing Assistance Plan and
4 Annual Action Plan when making program allocations and
5 conducting other activities in the county.
