A MOTION to grant an electrical power system easement to Puget Sound Power & Light Company.

WHEREAS, the King County parks division has requested Puget Sound Power & Light Company to construct and install electrical power system improvements over, under, upon, and across portions of the King County Fairgrounds herein described, and

WHEREAS, Puget Sound Power & Light Company requires an easement for the installation of the electrical improvement on the King County property involved, and

WHEREAS, the electrical system improvements will improve service to the King County fairground facilities, and

WHEREAS, It will be to the county's advantage to grant Puget Sound Power & Light Company the requested easement for a consideration of mutual benefits;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The county executive is authorized to execute and deliver the necessary electrical power system easement granting to Puget Sound Power & Light Company an easement for an electrical power system with necessary appurtenances over, under, upon and across the following described properties situate in King County, Washington:

PARCEL A

The West half of the SW quarter of the NE quarter of Section 30, Township 20 North, Range 7 East, W.M.; EXCEPT the South 10 feet, AND EXCEPT county road.

ALSO, beginning at the NE corner of the SW quarter of the NE quarter of said Section 30; Thence West 50 feet to the true point of beginning; Thence South 54 feet; Thence West 92 feet; Thence South 210 feet; Thence West 58 feet; Thence South 320 feet; Thence S 89° 34' 00" W 30 feet; Thence N 00° 26' 00" W 52.80 feet; Thence N 12° 15' 00" W 70.93 feet; Thence N 40° 51' 00" W 79.67 feet; Thence N 80° 50' 00" W 156.23 feet; Thence S 22° 21' 00" W 152.53 feet; Thence S 05° 26' 00" W 325.40 feet; Thence S 89° 34' 00" W 93.05 feet; Thence North 841 feet to the NW corner of the West half of said subdivision; Thence East to the true point of beginning.

PARCEL B

The South 15 acres of the NW quarter of the NE quarter of Section 30, Township 20 North, Range 7 East, W.M., in King County, Washington, EXCEPT that portion thereof described as follows:

Beginning at the NW corner of said subdivision; Thence South 803 feet to the true point of beginning; Thence South 138 feet; Thence East 435.6 feet; Thence North 138 feet; Thence West 435.6 feet to the point of beginning.

ALSO, EXCEPT the East 20 feet of said South 15 acres and EXCEPT the West 30 feet thereof conveyed to King County for road purposes by deed recorded under Auditor's File No. 149082.
