MOTION NO. 6985

A MOTION approving the sale of Carnation Cable TV, Inc., to All Points Associates, Inc., and authorizing the King County executive to enter into a franchise transfer agreement transferring the control and operation of the Carnation Cable TV, Inc., King County cable television franchise to All Points Associates, Inc.

WHEREAS, Carnation Cable TV, Inc., owns and operates a cable television system in King County pursuant to a cable television franchise granted by King County, and

WHEREAS, the cable system operated by Carnation Cable TV, Inc., is pursuant to King County cable television franchise number 5598, and

WHEREAS, Carnation Cable TV, Inc., has agreed to sell its assets to All Points Associates, Inc., and

WHEREAS, upon the sale of the assets of Carnation Cable TV, Inc., All Points Associates, Inc., shall comply with the terms and conditions of King County cable television franchise number 5598. Furthermore, All Points Associates, Inc., unconditionally guarantees the performance of any and all obligations, terms, and conditions of said cable television franchise number 5598, of which the first sheet is attached hereto and the full text of said franchise agreement, which is on file in the office of cable communications of King County, is incorporated herein by reference and made a part hereof;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The sale of assets by Carnation Cable TV, Inc., to All Points Associates, Inc., is hereby approved and the King County executive is authorized to enter into an agreement consenting to the transfer of King County cable television franchise number 5598 operated by Carnation Cable TV, Inc., to All Points Associates, Inc.

1 If within 30 days after passage of this motion, All Points
2 Associates, Inc., shall have failed to sign said franchise
3 transfer agreement, then this approval of said sale and the
4 agreement shall be null and void.

5 BE IT FURTHER MOVED,

6 The terms and conditions of the franchise being transferred
7 to All Points Associates, Inc., shall be subject to the
8 provisions of the King County cable communications ordinance as
9 codified in K.C.C. 6.27A, and the administrative regulations
10 which implement the ordinance. Any terms or conditions of the
11 franchise which are in conflict with the ordinance or
12 implementing regulations shall be resolved in favor of the
13 ordinance or regulations unless specifically exempted by
14 agreement authorized by the executive or authorized designee.
