M., Thence North 1°03'25" East along the West line of said subdivision, 822.34 feet to the northwest corner of the South 25 acres of said subdivision and the True Point of Beginning; Thence continuing North 1°03'25" East 450.00 feet; Thence South 89°14'52" East parallel with the South line of said subdivision a distance of 450.00 feet to the North line of the South 25 acres of said subdivision; Thence North 89°14'52" West along said North line 450.00 feet to the True Point of Beginning.
