A MOTION authorizing the County Executive to effect the transfer of certain county-owned open space and drainage detention sites to the City of Bellevue.

WHEREAS, King County owns certain parcels of land which were deeded or dedicated for open space or drainage detention sites, and

WHEREAS, the City of Bellevue has recently annexed certain areas of King County into their corporate boundaries, and

WHEREAS, there are ten county-owned sites lying within the annexation area which the City of Bellevue wishes to manage and maintain, and

WHEREAS, it is determined to be in the best interests of the citizens of King County to execute said transfer, and

WHEREAS, the county council finds that it is no longer necessary for King County to own and manage the subject properties.

NOW THEREFORE, BE IT MOVED by the Council of King County:

The county executive is authorized and directed to execute the necessary documents to effect the transfer of the following described properties to the City of Bellevue in consideration of the city's commitment to manage and maintain the properties for their intended purposes:
