A MOTION directing the Department of Planning and Community Development to prepare a community plan revision study pursuant to K.C.C. 20.12.070 for the consideration of the property known as Tax Lots 42, 47, 84, and 85 located in Section 15, Township 26N, Range 5E of the Northshore Community Plan.

WHEREAS, the Northshore Community Plan was adopted in August of 1977 by Ordinance 3325 and the area zoning was adopted in June of 1981 by Ordinance 5534, and

WHEREAS, the land use designation for the property, which legal description is provided as Attachment B, is industrial and the zoning is MP-P, and

WHEREAS, the Northshore Community Plan and P-suffix zoning conditions require that development of the property be compatible with surrounding land uses, and

WHEREAS, past efforts to develop a business park on this property within the existing zoning has met strong community opposition, and

WHEREAS, the owners of the properties would like to respond to the developmental concerns of area residents, businesses and King County, and

WHEREAS, the owner of this property has examined alternative concepts for development that compliment surrounding land uses (wineries, agriculture and recreation), and

WHEREAS, a master planned community of "Country French" design that includes multi-family dwellings, specialty shops, mini-wineries, professional offices and a restaurant is now proposed and appears to have some community and neighboring property owner support, and

WHEREAS, the proposed development includes extensive water and landscaping in its regard for open space, recreation, the Sammamish River and valley agriculture, and

WHEREAS, K.C.C. 20.12.060 through K.C.C. 20.12.080 establish the procedures and criteria for the consideration of community plan amendments, and

WHEREAS, the criteria identified in K.C.C. 20.12.070 for advancing a plan amendment study has been satisfied, and

WHEREAS, it is in the public interest to prepare a community plan revision study of limited scope to further the King County goal of sensitivity and compatibility in development of this property with surrounding land uses;

NOW, THEREFORE BE IT MOVED by the Council of King County:

The department of parks, planning & resources is requested to complete a revision study for the properties in the Northshore Community Plan area known as Tax Lots 42, 47, 84, and 85 located in Section 15, Township 26N, Range 5E as described in Attachment A and B.


