MOTION NO. 7355

A MOTION establishing the role and membership of the Hylebos Creek Basin Plan Citizen Advisory Committee.

WHEREAS, the Hylebos Creek basin plan will be completed under the Surface Water Management Program as established by King County Ordinance 7590, and

WHEREAS, involvement of citizens is an important way to incorporate community needs and priorities into basin plans;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

A. There is established a eight-member Hylebos Creek Basin Plan Citizen Advisory Committee, composed of the individuals listed in attachment A.

B. If a member is unable to complete his or her term, a reserve member from the list in attachment B will replace that member.

C. All committee members shall be subject to the disclosure provisions of K.C.C. 3.04.050.

D. The committee will be advisory to staff. Consensus between staff and the advisory committee is a goal of the plan process.
