5 A MOTION authorizing the County Executive to make  
6 an application for funds in the amount of \$50,000,  
7 to fund one project for enhancement of mental health  
8 services to black ethnic minorities within the State's  
9 priority population.

10 WHEREAS, the State of Washington Department of Social and Health Services  
11 has made available an award of \$50,000 for the enhancement of mental health  
12 services to black ethnic minorities, and

13 WHEREAS, Department of Social and Health Services, pursuant to its statu-  
14 tory authority, selected King County as one of the counties eligible to apply  
15 to participate in the enhancement of mental health services to black ethnic  
16 minorities within the State's priority population, and

17 WHEREAS, an acceptance of the proposal from King County by the Department  
18 of Social and Health Services' Mental Health Division will make available up  
19 to \$50,000 for the period April 1, 1989 through March 31, 1990 with addi-  
20 tional funds to be made available to continue the project for a total of  
21 three years for services to black ethnic minorities with severe psychiatric  
22 disabilities in King County, and

23 WHEREAS, a local mental health agency will be selected to provide these ser-  
24 vices through a Request for Proposal process, and

25 WHEREAS, enhancement of mental health services to black ethnic minorities  
26 within the state's priority population funds will assist the county to expand  
27 services to black ethnic minorities with severe psychiatric illness in a  
28 manner consistent with the 1987-89 Biennial Mental Health Program Plan adopted  
29 by the council in Motion No. 6893 on June 22, 1987;

NOW, THEREFORE, BE IT MOVED by the council of King County:


A. The King County executive is hereby authorized to make application on behalf of King County for funds in the amount of \$50,000 to the Department of Social and Health Services for enhancement of mental health services to black ethnic minorities within the State's priority population.

B. The King County executive is hereby authorized to file and execute such applications and enter into and execute such contracts as are required by the grantor.

C. The King County executive is also authorized to enter into and execute such subcontracts as are necessary for the implementation of the project.
